- For Executive Level L1 FTE position, as on **28.02.2023**, minimum 5 years of relevant work experience (post-qualification) for candidates possessing Graduate (B.E. / B.Tech) in relevant discipline and minimum 10 years of relevant work experience (post-qualification) for candidates possessing Diploma in Engg. in relevant discipline is required.
- For Executive Level L2 FTE position, as on **28.02.2023**, minimum 10 years of relevant work experience (post-qualification) for candidates possessing Graduate (B.E. / B.Tech) in relevant discipline and minimum 15 years of relevant work experience (post-qualification) for candidates possessing Diploma in Engg. in relevant discipline is required.

**Upper Age Limit (For General/ EWS)** (as on **28.02.2023**): 35 years for Executive Level L1 and 45 years for Executive Level L2. Age Relaxation for reserved categories as per Government Guidelines.
