3. **Application Fee:** A Demand Draft in favour of “**INDIAN INSTITUTE OF PACKAGING**” payable at Mumbai, for Rs.1000/- for General Candidates, Rs. 500/- for OBC Candidates and Rs. 250/- for SC/ST Candidates to be submitted along with the application form. Any application received without application fees will be rejected & fees once paid shall not be refunded under any circumstances.
4. Any information submitted by an applicant in his/ her application shall be binding on the candidate personally and he/she shall be liable for prosecution/ civil consequences in case the information/ details furnished by him/ her is found to be false at a later stage.
5. Candidates are required to submit ‘No Objection Certificate’ from the present employer, if presently employed. 7. Action against candidates found guilty of misconduct/use of unfair means:
